COMMISSIONER'S REPORT: Staff Liaison Christopherson filled in for the Commissioner's Report. **Water Gremlin:** Due to the ongoing situation with Water Gremlin emitting over the state regulated amount of TCE into the air, residents in the community are concerned with potential health effects. Town Board and City Officials have been conducting meetings and hearings with Water Gremlin, concerned citizens, Ramsey County Officials and State Representatives to determine the best course of action. **MINUTES OF A MEETING OF THE JURISDICTIONS

I. CALL TO ORDER

The meeting was called to order at 8:00 a.m. by Acting Chair Perrault at the Ramsey County Sheriff's Office Patrol Station, 1411 Paul Kirkwold Drive, Arden Hills.

II. APPROVAL OF AGENDA

Approval of the February 21, 2019 Contract Communities Committee Meeting: A motion was made by Robertson and seconded by Schwerm. Motion carried.

III. APPROVAL OF MINUTES

Approve Minutes of January 17, 2019. A motion was made by Schwerm and seconded by Robertson. Motion carried.

IV. WEIGHT RESTRICTIONS – ENFORCEMENT UPDATE

- Mike Casey noted that the weight restrictions will likely stay in place until mid-March. Moe is working on being certified.

- Most complaints that will be received are from construction traffic.
- There was a discussion over general overweight versus actual weight.
- Asked for notification if cities give authority for some exceptions to give traffic deputies heads up. Also asked for cities to have signs up properly.
- Speed concerns not as bad with current weather.
- Talked about general parking issues during snow events.

V. CRIME PREVENTION REPORT AND DISCUSSION OF 2019 PRIORITIES

- Update from Crime Prevention is attached
- Schwerm discussed a Tobacco license issue. Asked if they can get police reports to our city administration so they can properly issue fines. Fines are handled through cities, not attorney's office. Shoreview handles tobacco issues with a heavy hand and needs all the tools it can get in it's tool chest. Discussed tobacco 21 rules. Flavor tobacco was discussed.
- Perrault asked about Neighborhood Watch Signs. Wanted to get an idea of the process. Who gave the go ahead to install a sign? Public works, city admin, or RCSO. Generally it's believed the RCSO says ok and public works installs. The conversation was invigorating.
- Robertson enlightened us about the struggles related to hot dogs in parks with deputies. If there were hamburgers, it's suspected this conflict would never have unfolded as it did. Hopefully there's a solution in the near future or there may not be hot dogs in North Oaks for the foreseeable future.

VI. COURT FINES & ADMINISTRATIVE FINES REVIEW FOR YE 2018

- The city managers were presented a report on State fines received so far. There was a discussion about the pending legislation that's trying to be rectified. Ramsey County gets 50% of fine and all other counties get 2/3's. Hopefully this is resolved. No significant concerns about the report.

VII. FOURTH QUARTER 2018 CRIME STATISTICS

- Waldo presented. He indicated there are no major issues. Rest assured Shoreview will be able to successfully receive awards recognizing it's tremendous livability.

- There was a discussion about the number of medical calls increasing across the board. We discussed our feelings about Deputies Responding to medicals. All agreed that Deputies should still respond to medicals vs. having medic's advise whether they need deputies or not..
- Schwerm asked if tickets were included in totals. Yes!
- There was a discussion about some frustration by the deputies with issuing/writing tickets due to a software issue.
- Schwerm discussed how BCA lumps all cities together with Crime Stats versus separated by cities. Schwerm was assured he would be successful during award season. Ramacher said that that ability should change in the near future.

VIII. NIBERS UPDATE

- Zuecher merged with Central Square. This has posed a challenge with software integration and merging with BCA and NIBERS system.
- Deputies are frustrated and report writing is time consuming.
- NIBERS is a federal requirement. NIBERS compliance is under 4% errors which is a positive. Long-term better accuracy, better reports, more detail.

IX. OTHER BUSINESS

- **RCSO UPDATES**
 - i. Waldo indicated there are 7 new deputies in academy. Snow issues. Sharing with Public Works and RSCO makes things chaotic.
 - ii. Ashlee Bryant said there is a new coding for calls, ESM – Electronic Sexual Misconduct. It's a new term. A grant was received to pay for this position and is shared through the whole county. This position focuses on sexual violence against women. The new code will likely lower the total of CSC cases. Victim focused as one investigator is with victim through the whole case.
 - iii. Admin Hearings – Group is in need of a new administrative hearing officer. Could be a former Judge or Mediator. Watson volunteered to track down options.
 - iv. New finance staff is on board, Mike Webster. Discussed fund for long range capital express. Annual reconciliation could be a source if revenue is significant. Most cities incorporated reconciliation into the budget.

- v. Nordstrom discussed recoding of issues and backfilling investigator that's on the grants.
 - vi. Ramacher discussed a Special Investigative Unit to focus on career criminals. Will be headed by Rich Clark.
 - vii. There will be a renewed focus on outreach with youth.
 - viii. A RCSO Emergency Manager was recently hired. Deano Garem – St. Paul Firefighter. One focus will be School Safety. There's a statewide conference being held on it.
 - ix. All these new initiatives with likely take staff aware from patrol. Concerns have been raised on backfilling positions. Contract cities ran short a lot in the past but it is not ideal.
 - x. There was a discussion about getting more officers on bikes. New squads will be delayed due to state contract issues. May purchase through dealerships directly.
 - xi. A concept was introduced to fund PT traffic deputy during summer - Kevin Otto. April 1st through September 30th. Focus on speed and distracted driving. Otto's approach is remarkable. Had done in the past. Concern was raised about cost. Would be nice to know reconciliation before moving forward with concept and could that be incorporated there. Concern about using these funds if sheriff wants money for body cameras.
- COMMUNITY UPDATES
 - i. General Updates were provided.


Thanks for forwarding. The initial proposal included a 5% increase for the first year of the contract and then a 2-3% increase per year following that.
