The meeting was called to order at 6:00 p.m.

Present: Anderson, Brueckner, Griffin, LeBlanc, Lee, Linn; Advisor: Christopherson

Absent: Pozzini-Stedman with Notice

APPROVAL OF AGENDA (Additions/Deletions): LeBlanc moved approval of the agenda as submitted. Linn seconded. Ayes all.

APPROVAL OF MINUTES OF SEPTEMBER 5, 2019 (Additions/Deletions): Brueckner moved to approve the Minutes of September 5, 2019. LeBlanc seconded. Ayes all.

CONSENT AGENDA: LeBlanc moved to receive the Consent Agenda as follows: A) Receive Animal Control Reports; B) Receive Ramsey County Sheriff's Reports; C) Receive Sheriff's Contract Group Minutes; D) Receive White Bear Lake Fire Department Report. Brueckner seconded. Ayes all. It was noted that the compiled reports will be done in November to save on paper. If the Commission has any inquiries and would like more information, that can be arranged.

COMMISSIONER'S REPORT: Town Board Supervisor McCune was present to report on important decisions the Board has been discussing and making. **Water Gremlin** continues to be in the news; this time they are telling their side of the story. At the September 16th Town Board meeting the Board made a resolution of the Town's official position on Water Gremlin, stating clearly that the Minnesota Department of Health and the Minnesota Pollution Control Agency are the agencies with authority. Moreover, the Board is looking at a **comprehensive view of water quality**. The Town Engineers have been looking into which approach the Township should take when it comes down to the MDH's health based guidelines. Last fall the MDH put manganese, a naturally occurring element, on the list of elements to have under a certain amount. The Engineers came up with 6 different options the Town could do ranging from nothing, since it's just a guideline currently, to building a new treatment plant. Either way, it will be costly, so over the next year or so there will be discussion on this topic. **Water meters** are still being replaced and the contractors are obligated to finish up installations by the end of October. Routes 4, 5, and 6 are in sequence for replacement.

The **pavement management plan** for 2019 is nearly complete, with discussion of 2020 at the forefront. There was a neighborhood meeting in September to see where the residents are regarding the project. The construction for 2020 will be much more intensive, with 121 homes being assessed. Questionnaires were sent out to those 121 homes and 51 have come back, nearly 50%. The responses are split, with some in favor of narrower streets to cut costs and some in favor of wider streets to improve safety.

There was discussion on the Weston Woods/Gilfillan Court no parking signs request. It was noted that there have been 2 proposals from local companies to expand along Centerville Road, south of J and north of H2. The **budget for 2020** has been a topic as well. There will be more discussion on the budget as it gets closer to completion in December of 2019. It was noted that

the last 3 years the budget has gone down. The same will happen in 2019. There was discussion of crime in the metro area and the proposed 6 new sheriff's deputies for 2020.

TOWNSHIP DAY – REVIEW: The Town Clerk and the Commission discussed their experiences at Township Day 2019. There was discussion on the child who broke his arm, potential legal situations with the Township, vendor, etc. There was discussion of the overall safety of Township Day. There was discussion of not having bouncy houses or animals so there is no liability. It is too soon for decisions at this point, but there will be more discussion before Township Day 2020.

The Public Safety Commission donated the iPad, and it was noted at a loss. There was reflection on what would potentially be a good seller for future events. There was discussion on potentially getting a gambling license so there could be a raffle next year.

WATCH FOR CHILDREN SIGN REQUEST – UPDATE: The Town Clerk reported that staff has executed the request. The “deaf child” sign on Otter Lake was replaced with a “watch for children” sign since there hasn't been a deaf child there for 10 years. There was discussion on hypothetical situations and the Commission all around wondered how the Township could receive sooner notice of these situations.

It was noted that if any case regarding signage is within the Township's jurisdiction staff would have the authority, but have to run it by Ramsey County if it affects the flow of traffic.

ANNUAL TOUR – DISCUSS LOCATION: The Commission discussed previous years' annual tours. A few locations were discussed from previous years like the gun simulation, Lake Elmo airport, highway helicopters, the detention center, local businesses, Ramsey County Courthouse, Lino Lakes Fire Department, and others. The Town Clerk received no email suggestions. Brueckner suggested touring White Bear Center for Performing Arts. There was discussion of potentially touring Water Gremlin. It was the consensus that now is not the right time for that, though the Commission was intrigued of the idea. There was discussion of touring parks, get to know the parks' equipment, see whether there is ADA accessibility options at every park, etc. There was discussion of meeting with White Bear City's Safety Commission to discuss safety items that are common interest to the community.

It was the consensus that the Commission will wait until the spring to tour parks, but that that sounds like a good idea for a public safety tour.

LIAISON REPORTS: Rich Brueckner reported that Otter Lake Elementary School's annual carnival is Friday, April 3rd. He notified the Sheriff's Crime Prevention of the event and noted that they may participate. There was discussion of whether or not it was feasible to get the fire marshal to have the White Bear Fire Department trucks set up for events like that.

Connie Anderson reported that there is nothing new at the fire department. The fire truck that was damaged last month has been repaired and is back up and running. She noted that one of the newer ambulances at the south fire station had a ding in the bumper and so staff had looked back on the cameras that had shown the driver who backed up into the curb.
