**AN ORDINANCE AMENDING ORDINANCE NO. 54 OF THE  
TOWN OF WHITE BEAR, ADOPTED DECEMBER 15, 1985,  
AS AMENDED, BEING AN ORDINANCE ESTABLISHING FEES  
AND CHARGES TO BE PAID IN THE TOWN OF WHITE BEAR,  
RAMSEY COUNTY, MINNESOTA**

**THE TOWN BOARD OF SUPERVISORS OF THE TOWN OF WHITE BEAR ORDAINS:**

**SECTION 1. AMENDMENT.** Section 2-1 – Building Permits, Section 2-2 A & B – Grading Permits, 2-3 – Plumbing Permits, 204 – Gas-Heating-Ventilation Permits and parts of Section 3-4 – Miscellaneous Licenses – Annual & Contractors Licenses are amended to read as follows:

**2-1 - BUILDING PERMITS** - Per Town Board Resolution

**2-2 - GRADING PERMITS (Plan Review & Fees)** – Per Town Board Resolution

**2-3 - PLUMBING PERMITS** - Per Town Board Resolution

**2-4 - GAS-HEATING-VENTILATION PERMITS** – Per Town Board Resolution

**3-4 - PARTS OF MISCELLANEOUS LICENSES – ANNUAL AND CONTRACTORS LICENSES** – Per Town Board Resolution

**SECTION 2. SEVERABILITY.** Should any section, subdivision, clause or other provision of this Ordinance be held to be invalid by any court of competent jurisdiction, such decision shall not affect the validity of the Ordinance as a whole or any part hereof, other than the part held to be invalid.

**SECTION 3. EFFECTIVE DATE.** This Ordinance shall take effect and be in force from and after its passage and publication.
