Outdoor Display of Fireworks / Pyrotechnic Special Effects Application

Instructions: Return complete application with requested copies of supporting documentation within 15 days prior to the date of the display. Any permit granted shall be non-transferable.

Required Attachments: The following attachments must be included with this application.

- Attach proof of a bond or Certificate of Insurance in the amount of at least \$1,500,000.00
- Attach a diagram of the ground at which the display will be held.
 - This diagram (drawn to scale or with dimensions included) must show the point at which the fireworks/pyrotechnics special effects are to be discharged; the location of ground pieces; the location of all buildings, highways, streets, communication lines and other possible overhead obstructions; and the lines behind which the audience will be restrained.
- Attach names and ages of all assistants that will be participating in the display.
- Attach application / inspection fee of \$100. Check payable to White Bear Township. Fee waived for White Bear Township sponsored community fireworks displays.
