Rebate Program Guideline

- Rebates are only available to White Bear Township water utility customers with non-delinquent accounts.
- The system must follow the Township's year around watering restrictions. Odd number houses water on odd numbered days and Even numbered houses water on even numbered days. Only during the hours of 6:00am to 10:00am and 6:00pm to 10:00pm.
- Rebate maximum is \$200 per replaced controller or \$150 per sprinkler body or irrigation system audit and is based on pre-tax pricing.
- Irrigation System Controller Replacement with a WaterSense Labeled Controller or Irrigation system audits by a WaterSense audit-certified professional that result in an Irrigation System Controller Replacement with a WaterSense labeled controller, and may include replacement of broken or inefficient sprinkler heads.
- Itemized invoice or receipt documenting the make and model of sensor are required. Failure to provide information may result in disqualification.
- The Township is not responsible for sensor performance or water savings. No warranty or guarantee is provided.
- The Township has the right to discontinue or amend the rebate program at anytime.
